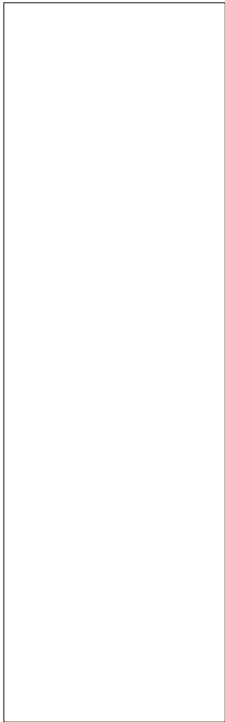

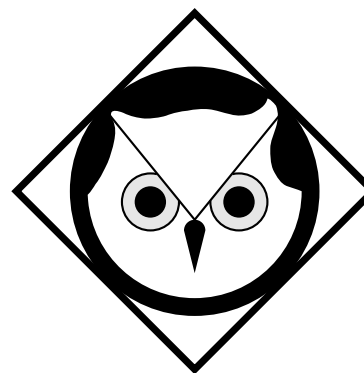

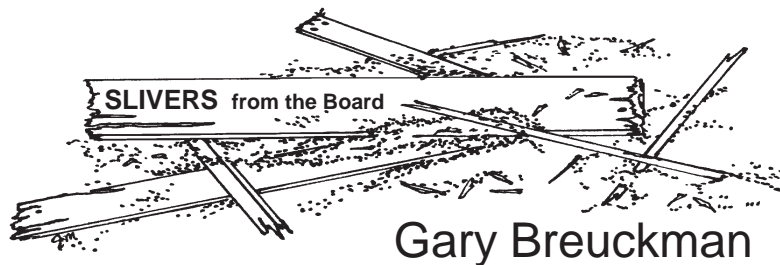

Director's Notes From July 13, 2008 Meeting in Deforest

PRESIDENT REPORT— Moved the AWSC office from Appleton to Deforest. Went to the D.C. Fly-In—. Met with all of Wis. Congress Staff's. Had good meetings. International Congress— Talked to New York about the “ Club Assistance Program”, our CAP PROGRAM. Have a program that they think will work for Wis., but has to go to the DNR, first, for approval, before the Directors get to see or hear about the program.

OFFICE MANAGER— Thanked all Director's and AWSC members for welcoming her to our organization. This was her 1st big AWSC event.

COMMITTEE REPORTS

LEGISLATIVE— Personal Property Tax, on Groomer's will **EVENTUALLY EXPAND OVER THE WHOLE STATE**. AWSC has plans, to **TRY**, to get a Legislation change passed, so this personal property tax will not take place. What a definition of a State Trail is, does not include the word Snowmobile. Plans are to get the word snowmobile added to the definition. The out-of-state fees now go to the general snowmobile fund. Plans are to change this through legislative action to go to the supplemental fund. Earliest this could happen, would be for the fiscal year 2010. Plans are for a Legislative day at the Capitol in January sometime, on a Tuesday, Wednesday or Thursday. Buses may be available, or Co.'s could get a bus on their own. 30 to 40 people needed to fill a bus.

SAFETY/EDUCATION— Will have 1 session at Fall Workshop. Hope to have New student/Instructor manuals there. Most instructors feel a DNR Warden, is not needed at their Safety Classes. Most Instructors classes have at least 1 person that can do a good job in teaching the Law Portion of the class.

Unanimously Approved & Adopted by the AWSC Board of Directors on 7-13-2008 Meeting

- 1) THE AWSC SUPPORTS SAFE; RESPONSIBLE SNOWMOBILING.
- 2) THE AWSC SUPPORTS THE EDUCATION OF SNOWMOBILERS AND THE GENERAL PUBLIC ABOUT SAFETY AND RESPONSIBILITY ON THE SNOWMOBILE TRAILS.
- 3) THE AWSC SUPPORTS LAW ENFORCEMENT AND ENFORCEMENT OF EXISTING LAWS.

We suggest you only say these 3 statements to protect our sport. The Media has a way of twisting whatever we say to them.

SAFETY SCHOOL

The Snobirds will again be offering snowmobile safety classes this winter. The classes are conducted by qualified instructors, from the Snobirds, who are certified by the State D.N.R.. Satisfactory completion of the class meets the D.N.R. requirements.

"Any person who is at least 12 years old AND who is born on or after January 1, 1985 is required to possess a *valid Snowmobile Safety Certificate* in order to operate a snowmobile on public trails, lands or frozen waters. You must carry the certificate while riding and you must display it to a law enforcement officer when requested."

Enrollment is open to young persons 11 years of age and older. As this training is important to public and personal safety, a parent or guardian is welcome to attend with the son or daughter. There is a \$10 fee for registration and D.N.R. safety materials.

The course consists of three evening classes with subjects of snowmobile laws, ethics, terminology, maintenance, clothing, first aid, environmental and ecology problems.

We have two sets of indoor sessions scheduled this season. Total cost is \$10.00 The first set will be December 3, 10 and 17 at the Menomonee Falls Community Center, W152 N8645 Margaret Rd in Menomonee Falls. The second set of classes will be on January 7, 14 and 21. For reservations call Gary Breuckman at 414-442-4279. Classes run from 6:30 p.m. to 9:30 p.m. each night, and you must attend all three sessions to be certified.
