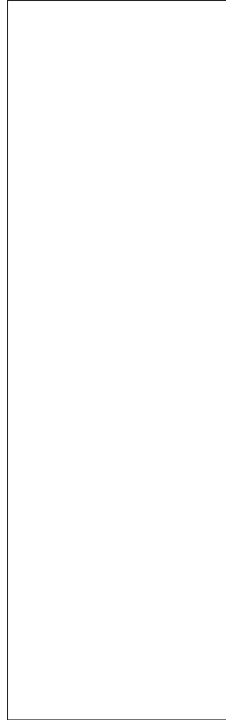

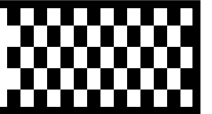

## Press release on Off-Trail riding and Trespass

The Association of Wisconsin Snowmobile Clubs (AWSC) encourages all snowmobilers to obey the laws. Early season riding, especially, has its share of individuals either unfamiliar with the trails or unfamiliar with the effort local club volunteers put into Landowner relations to establish the snowmobile trails and keep them open.

Where the snowmobile trails cross private property club members coordinate with the Landowner to establish access where the landowner allows. When snowmobilers enter that private property before the trail system is officially open, they are trespassing, and subject to whatever fines can be levied for the offense. When snowmobilers stray from the marked trail into other areas of that private property and/or CUT CORNERS, they are trespassing.

Trespass is only half the issue. The rest of the story is this: When a Landowner decides that too many snowmobilers don't respect their private property rights, they will close the trail. All of the work the local snowmobile club has done to establish the trail and establish good relations with the owner of the private property is lost. The trail is now broken. It may be possible to re-route the trail around the broken link. Sometimes it is not possible to re-route. If closure occurs after the trails are officially opened, or just before enough snow has fallen to open the trail, what can the local club do?

Some trails are established in road right-of-ways. When trails exist in those right-of-ways, the fields adjacent to those trails are not part of the trail. The owner of that adjacent property has not given permission for snowmobilers to operate on their property, or, has removed permission for a snowmobile trail across their property. Snowmobilers operating on that property are trespassing and subject to fines. Local snowmobile clubs work very hard to establish good public relations. One violator can damage that image. More than one violator can damage that image to the point that it may have a negative impact on other landowners and the local trail system.

**Bottom line - As a snowmobiler it is up to you to know when the trails you want to ride are open. It is up to you to know where the marked trails are and stay on the marked trails! DO NOT CUT CORNERS!!!!!! It's not just the violator who looks bad, but every snowmobiler who enjoys riding is affected.**

Loud pipes: Noise limit on a snowmobile is 78 dBA. Snowmobile owners with aftermarket pipes over 78 dBA are subject to a citation.

NOTE: Fines for violating snowmobile laws ranges from \$125.90 to \$2,000.00.....

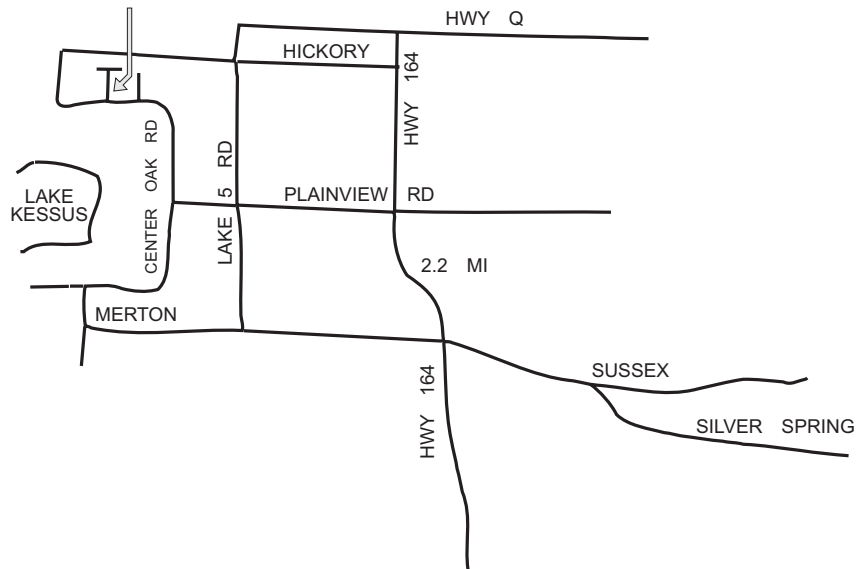
# Smelt Cleaning Party

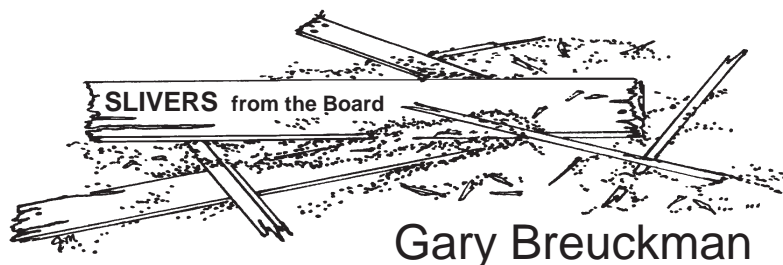
Thursday April 18<sup>th</sup>
